

DONATION AGREEMENT No. 1-2019

(hereinafter referred to as Donor).

Article 1

This Agreement establishes the mutual will of the Parties - the will of the Donor to assist the registered activity of the Recipient and the will of the Recipient to accept such assistance.

Article 2

The Agreement is concluded for an indefinite period of time. In accordance with this Agreement, the Donor shall deliver the orthopedic aids that will be collected to the Recipient, and the Parties hereby acknowledge that no compensation or consideration shall be due or paid to the Donor for its input.

Article 3

The Recipient shall use the received items only for the purpose of fulfilling its goals and mission, established in the Statute of the association, without acquiring any benefits from the distribution of the received items.

The Recipient shall also provide the Donor at any time, at its request, with all available evidence on the manner of conduct specified in the preceding paragraph hereof.

Article 4

For each delivery of the items referred to in Article 2 of this Agreement, the Parties shall separately arrange for the manner of delivery, the mutual obligations and the responsibilities related to the delivery, as well as the manner of compensation and covering the costs of delivery.



Article 5

This Agreement may be terminated by mutual consent as well as unilaterally by each of the Parties giving the other Party 30 days' advance notice.

Article 6

This Agreement is made in 2 (two) identical copies, one for each Party, and shall come into force on the day of its signing by both Parties.
